COUNTERPRODUCTIVE INTERNET ‘CAMPAIGNERS’.

Greetings, Friends.

Today, we received a forwarded text written recently by Vernon Coleman, a prolific author who seeks to stop the ongoing creep towards world government and the New World Order (nwo) takeover.

In common with Coleman's outlook, **Members of the Democracy Defined Restoration Campaign** are “*enraged by injustice, inhumanity and oppressive authority,*” and the Campaign's principal preoccupation is with the eternal ongoing necessity to be active in the principled human fight for freedom and equal justice.

Like many another contemporary commentator, Coleman chillingly exposes the inhumanity of the nwo. He talks about venal statist politicians' and government bureaucrats' collaboration with bank-controlled major corporations, and unconscionable villains within mainstream media who support and promulgate nwo disinformation.

Yet, for all the earnest eloquence he and others employ to raise people's awareness about the real and perceptibly-growing Orwellian threat to human freedom and the need to stop it, *nowhere* does Coleman propose *a realistic, effective solution and resolution* to this problem of global enormity.

Coleman: “We are all living in occupied countries. Most people don't realise it but we are victims of a coup. What we are seeing is the beginning of a new world order, a global reset, which involves a world government.”

“The first real step was the recent call for what Johnson, Macron, Merkel, etc., call a pandemic treaty, a global plan. Newspapers across the world carried a statement by 24 world leaders and the head of the World Health Organisation calling for an end to nationalism and to introduce mutual accountability, solidarity, peace, prosperity, health and security.”

“This is, we must never forget, a war which we are fighting. It is not a game. Their weapons are fear, built on lies and distortions and deceptions. They've been planning for decades, of course, but

the agenda now wrecking our lives began in the early 1990s. And, as I pointed out early last year, they want to reduce the world population by 90 to 95%. They'll do it any way they can - The people behind this evil have no mercy, no compassion, no feelings whatsoever.”
“The world government, the end of nations, the beginning of global technocracy is very close. *If we don't move quickly it will be too late.*”

“MOVE QUICKLY?”

“Move quickly,” says Coleman, but he does not propose any worthwhile move at all! How is the rank and file supposed to ‘move’ to solve the problem! For it is only the ‘ordinary’ people who are adversely affected by the nwo’s measures; the élite have got it made!

Yet, the ‘move’, the solution which is missed by Coleman and others, is already available to the great mass of the population. It is set into Magna Carta, their exemplary, world-respected 1215 Great Charter of English Liberties: they have but to (re-) learn it, understand it, *and statutorily restore it to full use.*

COUNTERPRODUCTIVE INTERNET ‘CAMPAIGNERS’.

There is no (*peaceful*) resolution to the problem of illegitimate government without Restoration of the Trial by Jury. (That takes widespread *unanimity of purpose* amongst the populace—as there was for Restoration of Trial by Jury through Magna Carta on June the Fifteenth, in the year Twelve Hundred and Fifteen.) Only through Restoration shall we achieve preclusion of the infliction of antidemocratic legislation by despotic government’s persecutory tool of enforcement: the *trial-by-judge*. Readers, if you appreciate these facts, then you will see that there is no (secular) cause more important than Restoration.

Without understanding *how* emancipation is *only* to be attained by Restoration, the unavoidable result is that people become *increasingly apathetic* in the absence of this knowledge. They face complete loss of their liberty, justice system, Constitution and rights because they have no realistic perception of *how* the proper rule of law is achieved. Witness the majority of enthusiastic patriots who are still passively submitting to political felons’ overthrow of their longstanding democratic culture. They remain docile and inactive despite the visibly progressing government destruction of their country.

Time, effort and resources expended on “campaigns” are *wasted* unless they are also *specifically* concentrated and deployed to educate and *achieve* the Restoration of Trial by Jury. Restoration must be the focus and inspiration of all efforts. With it, all will be resolved; without Restoration, there is **no** Solution. Although there might be some small apparent “wins” periodically, they will be inexorably reversed in due course by tyranny exerted through the statist technique of trial-by-judge or arbitrary government employee. Nothing, but *nothing*, short of **RESTORATION** is capable of stopping, let alone reversing, the ever-gaining momentum of the runaway new world order juggernaut.

The books and talks by internet campaigners and so many other apparently well-intentioned people do raise *awareness* about the enormous problem of misrule, but to date *their efforts conspicuously lack specifying exactly what the only peaceful solution is.* For example, they exhort people, “to rise up and overthrow the culprits.” They urge people to, “get off their knees.”

Some remind people that the American Declaration of Independence expresses the moral certainty that if government fails the people, they have the right and even the duty to replace it—but to date all the froth of their speechifying ‘campaign’ efforts reveals that *they have no inkling of the real solution*. These internet campaigners are no closer to success than when they started up.

Unless we achieve *Restoration*, the ‘crime’ of criticising government (already-legislated in the EU) will see all democratic dissenting campaigners gradually disappear or be “removed” from the scene. So, these well-intentioned but misguided internet campaigners had best realign their sights without delay, to adopt and campaign wholeheartedly for Restoration.

IT COULDN'T HAPPEN HERE...

“The Felicity of Societies depends on the Constitutions of Government under which they live.”

Consider the experiences which befall folk who fail to emplace, restore or uphold Constitutional Common Law Trial by Jury:

“If it were possible for any nation to fathom another people’s bitter experience through a book, how much easier its future fate would become and how many calamities and mistakes it could avoid. But it is very difficult. There always is this fallacious belief: ‘It would not be the same here; here such things are impossible.’ Alas, all the evil of the Twentieth Century is possible everywhere on earth.”

“At what point, then, should one resist? When one’s belt is taken away? When one is ordered to face into a corner? When someone crosses the threshold of one’s home? An arrest consists of a series of incidental irrelevancies, of a multitude of things that do not matter, and there seems no point in arguing about one of them individually...and yet all these incidental irrelevancies taken together implacably constitute the arrest.”

“And even in the fever of epidemic arrests, when people leaving for work said farewell to their families every day—because they could not be certain they would return at night—even then almost no one tried to run away and only in rare cases did people commit suicide. And that was exactly what was required. A submissive sheep is a find for a wolf.”

“And how we burned in the camps later, thinking: What would things have been like if every state security operative, when he went out at night to make an arrest, had been uncertain whether he would return alive and had to say good-bye to his family? Or if, during periods of mass arrests, as for example in Leningrad, when they arrested a quarter of the entire city, people had not simply sat there in their lairs, paling with terror at every bang of the downstairs door and at every step on the staircase, but had understood they had nothing left to lose and had boldly set up in the downstairs hall an ambush of half a dozen people with axes, hammers, pokers, or whatever else was at hand? After all, you knew ahead of time that those bluecaps [armed police] were out at night for no good purpose. And you could be sure ahead of time that you’d be cracking the skull of a cutthroat.”

A laudable edict may express a tyrant's pretensions, but "*a tyrannical statute always proves the existence of tyranny.*"¹ **Trial by Jury may be utilised to preclude and expunge unjust laws, penalise unjust lawmakers and judges and render impotent every aspiring tyrant and demagogue (see DD, Chapter Four). Hence: the Cause for Restoration.**

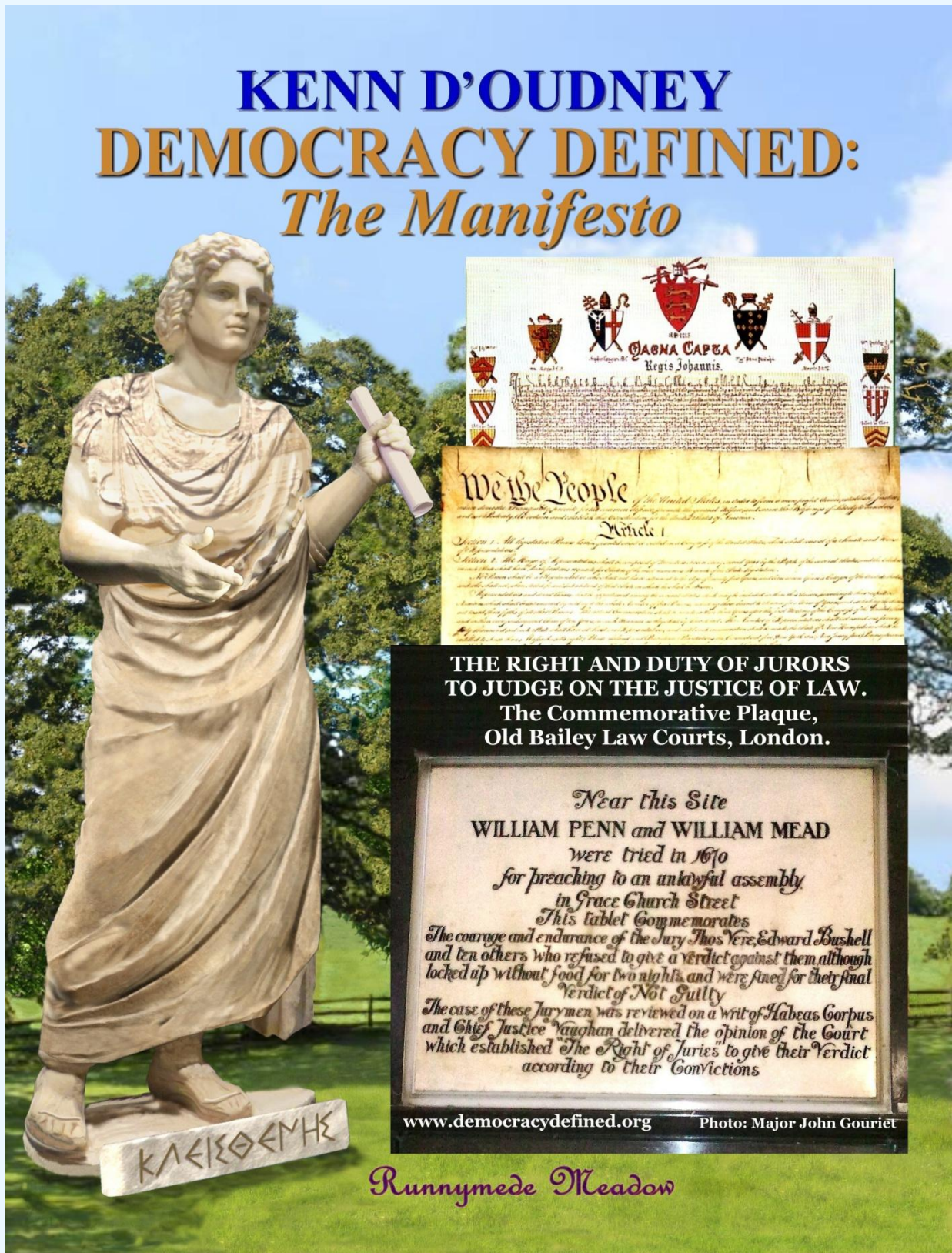

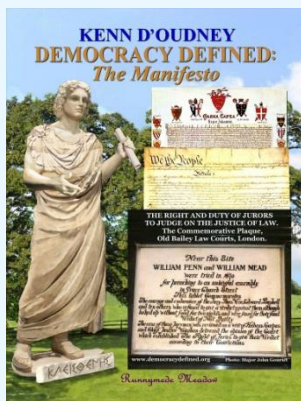


MAGNA CARTA MONUMENT Canberra, Australia
