1. WHAT 'THE GREAT RESET' MEANS TO US ALL.

Villainous U.N. Agendas 21 and 2030 together with the Davos "Great Reset" (of capitalism) adversely affect every 'ordinary' person throughout the West whether they are aware of this fact or not. These 'Agendas' are supported and activated by execrable political legislation passed at home at the national parliamentary level. Ratification by such national legislation *is history repeated*—it installs the dread anti-democratic Socratic-Platonic proto-fascist agenda. (This is given exposition in Chapter Six of Democracy Defined: *The Manifesto*.) Socrates and the Thirty Tyrants who, with their slaves and mercenaries overthrew the peaceful Athenian democracy, installed brutal authoritarian rule. Today, the clique comprising the 'New World Order' pursue installation of the same unacceptable *modus vivendi: absolute tyranny*.

Regarding such fundamental rights as to have and be part of a family; to possess the material fruit of one's labours such as property, housing, land, artefacts, farms and so on; *and the right to <u>equal</u> treatment for all before the law*; these latter are new world order targets for suppression. Yet this amounts to much more than mere suppression; *it is deep enslavement*. Regarding property, the truly moral picture is straightforward and well set out by **His Honour George Sutherland:**

"It is not the right <u>of</u> property which is protected, but the right <u>to</u> property. Property, per se, has no rights; but the individual—the man—has three great rights, equally sacred from arbitrary interference: the right to his life, the right to his liberty, the right to his property. The three rights are so bound together as to be essentially <u>one right</u>. To give a man his life but deny him his liberty, is to take from him all that makes his life worth living. To give him his liberty but take from him the property which is the fruit and badge of his liberty, is to still leave him a <u>slave</u>."

Knowledge of the relevant history and our constitutional law help us recognise the truly nefarious *modus operandi* of behind-the-scenes 'shadow' government of the 'new world order' for what it is. We have seen it all before and dread Socratic theory is now being put into practice. Enabled by the degenerate, judicable collusion of our politicians and judiciary, the nwo has now nearly realised the ambitions of those who are its masters. Latter-day subjection to the 'fascist' theory of the state as set out in Socrates' and Plato's gulag text, The Republic, is now all but upon us. Today, covert magnates manipulate the corrupted political marionettes within parliaments and our 'governing' Administrations.

Enforced, centralised statist ownership of 'everything' under control of *unelected*, *unaccountable persons* beyond the reach of the just rule of law is a state of tyranny unacceptable to all thinking citizens. Democracy Defined Members <u>know</u> installation of The Restoration Amendment Statute provides the well-proven, peaceful and effective Solution to Tyranny.

As the People's circumstances continue to deteriorate, the Restoration Message will inevitably become more widespread, for it recalls what our People can accomplish when they are "*united as one man*," as they were behind Archbishop of Canterbury Stephen Langton's collation of timeless *Articles of Common Law* into their 1215 Great Charter Constitution Magna Carta.

Permanent legal protection of the People against tyranny in all its manifestations is provided through the Constitutional Common Law Trial by Jury Justice System. People are becoming increasingly aware that the pseudo-moral nonsense preached at the populace by proponents of unsustainable and unacceptable Agendas have all the sincerity of the snake-oil salesman's deceit. As **Abraham Lincoln** is credited with saying,

"You can fool some of the people some of the time, and you can fool some of the people all of the time, but you cannot fool all of the people all of the time!"

Our folk know nwo Agendas give effect to de facto rape and utter suppression of the people. With Trial by Jury <u>restored</u>, all attempts to 'justify' and enforce the nwo inhumanity are doomed to failure.

The people's choice is stark: resistance now by way of The Restoration Amendment Statute or enslave yourself and succumb to a life of ever more taxation and intrusive government. Many people have heard about the UN's malfeasance and the self-aggrandising "World Economic Forum's" deluded "great reset," but with these being tamely accepted by all the major political parties and gradually put in place, folks are apathetic. They feel impotent to do anything to thwart its emplacement. *They know of no means by which to do so*. So, now, it is the job of all responsible citizens, Members of the Democracy Defined Educational Campaign, to lead and teach people to stand up for their own rights and heritage!

Once local electors have learned from <u>you</u> how Restoration embodies the sole peaceful, proven, effective <u>solution</u> to the bank-corporate, UN and statists' "great reset" tyranny, <u>and</u> about the enormous benefits which accrue to the people through Equal Justice, the Common Law Economy and the operations of the New National Bank, they will deeply appreciate it. They will support <u>you</u> (or your local group's candidate) for election.

Campaigners find it useful to point out that the English (*cf.* British) Constitution's authors and our forefathers, common and ennobled, knew, understood, defined and prescribed within the world-respected 1215 Great Charter Constitution Magna Carta, the sole peaceful means known to mankind for annihilating tyranny and establishing Equal Justice for All. Despite widespread illiteracy, no press (printing), let alone the Internet, the folk all knew they had the greatest conceivable heritage of liberty and equal justice. It was learned and passed from generation to generation throughout the land by word of mouth. The Gothic pan-European people understood and upheld the sole peaceful mechanism for creation of a uniquely egalitarian rule of law which is secular, universally applicable, and embodies the 'sine qua non', the defining factor, distinguishing genuine democratic¹ human Civilisation from the primitive barbarism of secular or theocratic despotism.

So, when canvassing on the doorstep or at meet-ups, to follow that 'great reset' crime discussed immediately above, here follows another educational topic with which to regale individuals or audiences: <u>The Restoration Program Statute</u> subjects all who form or work for government, Head of State notwithstanding, to liability to prosecution at Common Law Trial by Jury for any Acts of Malice Aforethought, *mens rea* (which is definitive Crime at Common Law). Any 'act' means not only legislation but also physical acts. This renders to the 'ordinary' folk the Power to hold government to Principles.

This can take you in turn into the subject of <u>how</u> Restoration of **the constitutional rule** of law <u>outlaws</u> Personal Taxation as <u>crime-by-government</u>, as follows...

Understanding of the constitutional rule of law exposes the fundamental flaw in, "*no taxation without representation*," the slogan often associated with the British New World colonists' revolution (ref. Democracy Defined, Chapter Six on Franklin, Colonial Scrip and the real reason for the War).

The greater the taxpayer or corporation, the greater their ability to achieve *representation*, lobbying and protection of *their* financial interests to the inequitably unlawful negation of the interests of others. We witness this behaviour constantly today.

Rather than the British New World Colonists' inadequate slogan, "*no taxation without representation*," *the guiding moral and legal principle is:* "<u>No taxation without consent</u>;" for to take a person's property, goods or money *without* his or her express *consent* is **Robbery**¹. Even when it is done by government, theft is still theft. When government adds *menaces* to the theft, that is to say, threat of penalisation, punitive enforcement, dispossession, fines and/or incarceration *for non-payment*, the crime of theft remains but definitively, theft is also compounded into <u>robbery</u>.

Further to the taking of a man's money without his consent being theft, to *assume* consent where no positive consent has been given (and has not been actively demonstrated to have been given), does not alter the fact that the taking of his money is still thieving. The position held by all our Western Constitutions, Australian, United States, Canadian, Irish, etc., and by Common Law, is that <u>fiscal legislation</u> installing compulsory personal taxation is illegal and such 'acts' constitute malicious judicable crime per se. *It could hardly be otherwise!* **"Thou shalt not steal"** has always been and remains in perpetuity a Prime Tenet of Common Law in all societies aspiring to description as 'civilised', sine qua non. *Assumption* by the government—however persuasively argued—affords neither moral nor legal justification for theft or robbery.

2. MOTIVATION AND INCENTIVE

Members, let the Democracy Defined Educational Message light a bright, confident, optimistic inspiration within you, because that beneficent Restoration Program by which life is transformed for the better for all your fellow men and women throughout the Land is **your** exclusive Message and Program.

Before we (any of us Members) start getting involved in discussing the nuts-and-bolts of our campaign to get representatives into parliament, let's first pause to consider the motives and incentives which spur all of us into taking an active part in the campaign. Participating in the parliamentary process is the natural way to proceed for all responsible adult self-governing men and women blessed with the moral sense of fairness and equal justice. *That* is manifestly the civilised, secular, traditional English (*cf.* British) democratic and Western way: the Constitutional Rule of Law.

Let's look at the <u>first</u> practical point usually raised in discussions about getting someone elected into parliament. It is about Spondulix. Dough. Shekels. Money! An MP's generous tax-free pay and pecuniary privileges for six months' "work" might well be enough to motivate some individuals into running for election as a local Independent Candidate—*and why not, you might say!* The fact is that a Restoration Campaign Patriot deserves that remuneration more than any one of the Traitors to the People and Constitution who today infest our parliaments, Lords and Commons; MPs and Senators (Australia). Once the subject of MPs' remuneration has been raised and dealt with, one turns to consider the more general motivation to support Restoration produced in the rest of us, and not just in those individuals running as our local representative.

The force of motivation felt by thinking people and participants in the Campaign is irresistible. This derives from the fact that we know exactly <u>how</u> We the People, <u>all of us</u>, will be recipients of profound benefit, well-being and security from a successful Campaign which culminates with parliamentary passage of The Restoration Amendment Statute. The sage Milton Friedman would not hesitate to point out that such *self-interest* is predictable, natural, and when it is guided by moral and altruistic constraints it is also beneficial, advisable and healthy. See Friedman versus Keynes, etc., in Chapter Six. **The Restoration Amendment Statute is set out on pages 247 to 253 of the Democracy Defined**

Such is the motivation behind DD Members electing someone local to be a powerful personification of Campaign Members' determination to restore and remedy our People and Country. Getting someone local into parliament to represent them and see the Campaign Manifesto enacted into law (statute), put into action and physical form* is an obligation felt by all. Campaigners willingly spend time and the few resources required for printing and photocopying campaign literature for *canvassing* and widespread distribution. * See Discussion Document (2) "A Miscellany of Observations and Notes on the Common Law Economy and the New National Bank.

The fact is indisputable: the Democracy Defined Election **Program** is far superior to and *unrivalled* by all the major Parties. It offers exponentially more benefit to citizens. If people ask you what your political views are regarding some current problem, event or politician, always couch your reply within the context of something <u>Constitutional</u> which teaches that restoring *the Common Law Powers of Plaintiffs and Jurors gives ordinary men and women sovereign power to hold government to the general Will and Principles of the People*. So, when canvassing, avoid becoming involved in parochial or transient current affairs aggravations, for *your* Program will *beneficially transform* current affairs!

However, there is a <u>second</u> electoral aspect to the subject of *money* with which Area Organisers need to acquaint themselves: it is that of raising funds sufficient to enable each and every Democracy Defined Independent Candidate to achieve his or her election.

Political Parties are heavily financed by the likes of the banking-corporate plutocracy and the unions—as a consequence their supporters have their wretched agenda decided for them *from the top down* by such élite groups. This has led to **the Illegality of the Status Quo** defined and set out in Chapter One of Democracy Defined: *The Manifesto*.

Keep in mind that, in contrast with the MPs of the major Parties, with a Restoration Campaign Independent Candidate installed in parliament, we know taxpayers' money is being put to good use.

The techniques for funding a local Independent Candidate's election are simple. Their <u>effectiveness</u> is confirmed by innumerable successful past and present independent candidates. As we shall see, the <u>quantity</u> of money required for effective independent canvassing—and success— is small and so easily raised.

Remember, Independent Candidates' success comes from having <u>the superior Program</u> on offer; regardless of how much money is chucked at the big parties' candidates!

3. STEP BY STEP.

People will take you and your Program seriously if you make it plain from the start that you intend to be (or get one of your group) elected to take the Democracy Defined Educational Campaign Message up to parliament, and from there on to the entire country.

Let's look at practical measures to take by which Independent Candidates get elected to parliament, and blend this in with subjects to raise in talks and meetings with electors.

Go step by step. To get someone elected, you only have to have <u>local</u> support. So, forming your local group of supporters is *your very first step*, and, to this end, forming your own e-mail list of local electors sympathetic to your Program is a priority.

4. AREA ORGANISER BROADSHEET #1.

Be bold and blatant telling people that you want to get yourself (or a specific local person) elected to parliament on The Restoration Amendment (statute) Program. To become an Area Organiser, get in touch with us. To create your innermost group, first of all you need to print out your customised Area Organiser's b&w double-sided Broadsheet #1 for handing around. Remember, it is <u>the contents</u> of the Program and how you describe it to people which will attract individuals to stand together in solidarity alongside you.

When you get The Restoration Amendment Program across to people for their first time of hearing, it will evoke positive responses in <u>some</u>. That is all anybody could expect—*and that is all you need!* Yes! It's all you need to make a start and get the ball rolling...

So, using print-outs of AO Broadsheet #1 together with chat and explanation of what those Five Items explained thereon bring as benefits to people today, recruit one local person, one ally, to begin the group with you.

Then, set your first supporter the goal of him or her getting one more local person on board.

And get your first supporter to get the new second supporter to do the same, and so on...

Although you need only one person to start with, the process is an exponential progression; it goes on by itself while you and your initial ally continue to canvass with Broadsheet #1 for more supporters by using and spreading the same technique.

Always ask new supporters to try to bring others on board; to get friends and family, and pals at work to join Democracy Defined and get behind your Independent Candidate. This is the way all 'movements' begin, and it is how Independent Candidates get elected. Remember the wisdom of anthropologist-philosopher Margaret Mead:

"Never doubt that a small group of thoughtful, committed citizens can change the world; indeed, it's the only thing that ever has."

Make sure core Members of your inner group are versed in the Campaign Philosophy and have become registered Members of the Democracy Defined Campaign. While out 'on the stump' canvassing, they might find it useful sometimes to show others their Member's Card. (It should be printed out in colour and encapsulated in plastic.) By the time you have ten in an inner group, numerous other local folk can be reached by your team of fellow campaigners sending/handing out virtual and physical Broadsheet flyers. Having got ten, then twenty and thirty become achievable, and more thereafter.

One wants a snowball to grow into an avalanche which smothers the bank-corporate financed Political Parties' duplicitous 'representatives' who betray and do not work in the interest of the British and Australian people. Intentionally or unwittingly, they actually machinate on behalf of the UN and the new world order bank-owners, the World Bank and International Monetary Fund (IMF) who are authors of the "great reset," UN Agendas 21 and 2030:

"You will [be allowed to] own nothing and you will be happy." (See as above.)

Guide your group and people to the wide selection of RESTORATION pamphlets freely available on the Democracy Defined ACTION & PAMPHLETS webpage.

It's constructive to get the message spread around to your group's contacts, friends and family wherever they may be, but when it comes to forming a group, *get your people to concentrate on campaigning to form a group <u>locally</u>, right in your constituency.*

When they see what <u>your</u> Program offers, people will come to support it: the Common Law Economy, No Personal Taxation, New National Bank issuance of *interest-free* loans, credit and currency, and dissolution of the National Debt, etc., through Constitutional Trial by Jury restored. Again, memorise and refer people to information in AO Discussion Document (2).

The AO Broadsheet #1 and EIS4 Trial by Jury leaflets are suitable to give to family, friends, colleagues at work, schools, blue and white collar workers, hospital staff, all ranks of the Armed Services, medical professionals, teachers, lecturers, shopkeepers and assistants, businessmen, sport, social and political clubs, and local and national media editors.

Having formed your expanding core group, you and your recruits chat to people on the doorstep, to parents and teachers, to people at their places of work, everywhere and anywhere. When conversation centres around the Democracy Defined Candidate's political intentions, always have your Area Organiser's Leaflets at the ready *to hand over*, so that the person to whom you are talking can see straightaway that you have a proper **Program** set out; **one which has visible support from people of the highest professional reputation**. They will read AO Broadsheet #1 later on and think about what you've been saying.

Explain how taking this Program to parliament is a natural aspiration to everyone who comes to know that you and the local group you form have adopted an Election Program *which shames those of all the current political parties.*

In canvassing, we have to get across to electors exactly what is *different and special about our campaign and candidates*: what is it that separates our Candidates from all the men and women selected by the Political Parties? Certainly, everybody wants greater prosperity! Emancipation from intrusive government! Equal Justice! Social and military security!

But how do we achieve these things any better than any party politician's program?

This is straightforward. <u>Your</u> Program uniquely puts our country into a <u>constitutionally</u> <u>correct</u> state—one of how it *should* be and how it should *always* have been. Emphasise that **ALL** *power returns to the People* through the Constitutionally recognised, citizen's Common Law right to sue any other citizen commoner cost-free at a Trial by Jury, politicians and judges notwithstanding. <u>This</u> is the People's Trial by Jury Justice System recognised by Articles of Common Law inscribed into the 1215 Great Charter of English Liberties, the world-respected inspiration and model for the U.S., Australian and other Constitutions. (Remind yourself of Articles 24, 36, 38, 39, 40 combined with Article 61.)

Although people know politicians constantly screw things up today, they do not know <u>how</u> to go about reversing the ongoing general deterioration of their way of life. **Taxation** and **Economics** (prosperity) play a central role in people's lives, and these are addressed by your Area Organiser Broadsheet #1 Program, whereby **Personal Taxation is prohibited**.

You will find it essential to explain how We the People's <u>control</u> over the Justice System by **RESTORATION** of their existing but currently illegally denied Constitutional Trial by Jury, promotes public well being in many unexpected, practical, down-to-earth ways.

One needs constantly to explain the *modern relevance* of the timeless Common Law Trial by Jury Justice System (set out in writing for the first time in Magna Carta 1215) keeping the present day English Parliament at Westminster (to which all the other British Home Nations currently subscribe) to the Principles of Liberty and Equal Justice; likewise the parliaments of Australia, Canada, New Zealand and others.

Those *Articles of Common Law* which remain binding and permanent (i.e., not affected by the passing of time), are specifically those which define and prescribe the Trial by Jury and how it is supposed to work. Inform folk that Common Law is <u>secular</u>: the Articles apply to, and are equally binding on, people of all religious beliefs and those who have none.

If a person shows interest in any of your comments or contents of your AO leaflet, then be sure to hand them the EIS4 Trial by Jury leaflet also. Ask for their e-mail to enable you to let them know developments and where and when there's a meet-up locally. Ask people if they'd like to come to a seminar, a meet-up where you can take your time to show them how they can start to make a real improvement to the circumstances of the people at large, and for themselves personally. Much can be achieved by getting a local person (you or your group's chosen Candidate) **elected** on your well-supported Program.

Tell them, the change has to start somewhere—let's start it here and now!

5. MEETINGS AND MOMENTUM.

Apart from an initial supply of AO Broadsheet #1 and EIS4 Trial by Jury leaflets needed in the forming of an inner group, one does not want to see Area Organisers relying on their own money to get the *expanded* group going. It is enough after all that Organisers still have to go about the place in their own time and at their own expense to make arrangements in advance for meet-ups and then in attending the meet-ups themselves. That already involves some small expenditures. AO's need to make sure every campaigner has a good clear copy (physical and digital) of your personalised AO Broadsheet #1 and EIS4 Trial by Jury leaflet as 'master copies' for making their own print-out and photocopies of recruitment handouts.

Meetings can be convened in no-cost and low-cost local venues, pub back rooms, village and school halls. Meet regularly and in different places in the constituency. Ask new members to bring along other new people every time. The demands for money are really small. At this stage, your group's campaigners will need to put themselves to the expense of photocopying the leaflets they intend to hand out canvassing everywhere they go; the supermarket and grocery store, the chemist's, work, office, factory and school...

After the group has begun doorstep canvassing and meet-up seminars, <u>colour-printed</u> or <u>colour-photocopied versions of the AO Broadsheet #1 flyer</u> should be made available for the local newspaper Editor and reporters, or any persons you particularly want to impress.

It should be noted up front that all the small costs of hiring a local venue (if they require any payment at all for hiring) need to be fairly shared amongst all the members of the growing inner group. So, as you begin to acquire more supporters chipping in to share such costs, the small contributions needed for this campaigning activity may actually decrease.

After your first active supporters are Members using the Broadsheet #1, EIS4, and Pamphlets to disseminate the attractions of The Restoration Amendment (statute) Program, you will be confident to take on other campaigning aspects such as journalists and political rivals.

Whether or not an election is imminent, <u>*now*</u> is the time for you to start creating some momentum. Begin with one loyal companion who then brings in one more to the fold.

There is a wondrous prize to be gained for all the People and the entire country following your successful outcome. Statist miseducation and wrong ideas are widespread about our Constitution and rule of law. Be sure to teach people that *history, heritage and the rule of law are on the side* of their Democracy Defined Educational Campaign.

Parliamentary RESTORATION of the timeless Five Items of Equal Justice for All (shown on AO Broadsheet #1) which are set within the Great Charter will heal and restore the United Kingdom and Commonwealth of Australia. People are crying out for Liberty and Justice, *but have to be taught* the authentic legal, lawful, all-powerful constitutional means by which they can achieve it. Other nations will follow your lead.

In politics, with the right Message, the sky's the limit.

6. RESTORATION: THE WAY AHEAD.

The Amendment's stipulations apply after it has been adopted as a statute for passage through parliament and is then enacted into law. The statute thus requires majority support in parliament, this being the goal for Democracy Defined Members and Area Organisers.

It is no more 'difficult' to achieve a majority for this Cause in parliament than it is to get any one single Independent Candidate elected: If the DD Campaign Program can achieve one Independent Candidate getting into parliament, then logically, others will follow.

Having seen the birth and progress of other groups and parties in the past, one notes that *it is the message and contents of a group's manifesto which can lead to its success*. Viz. Keir Hardie, whose original message in support of legislated fair treatment and good conditions for working men and women throughout all of service and production industries led to total reform in an age of horrific exploitation of the unprotected mass of the people.

However, there is another factor at play here: Rank and file members of the major political parties may deeply appreciate aspects of the Democracy Defined Program when they hear about them from you. For example, Common Law Economy Monetary Reform; No Personal Taxation; Operations of the New National Bank; No Inflation devaluing income, savings, investments and pensions; Recriminalisation of Usury; Restoration of Trial by Jury; the dissolution of the National Debt, and so on—intelligent folk latch onto the DD Program straight away, such as the endorsers referred to at the top of Broadsheet #1.

If any such people express approval of it, *make them come to you*. Get them to sign up as DD Members and join *your* campaign election group.

Our Program is antithetical to that of all the Parties who receive financial support from the banking-corporate conglomerate and unions. It is a waste of time, energy and resources to try to convert established MPs and the major Parties' local political agents to our way of thinking. Leave them well alone.

However, amongst local people who are enthusiastic about *your* DD Amendment Program, you will find some ready to quit their Party affiliation and ready to support you *as a rival* to the present sitting MP.

In due course, when your local group has got into its swing and becomes a talking point, the local MP will inevitably hear about you—but this well-financed person is likely to be complacent. They could not imagine that some Independent Candidate on a most unusual type of election Manifesto such as yours could knock the local MP off his high perch!

7. ELECTION DAY IN SIGHT.

An election day is always just down the road. It's never too soon to get going!

In due course, you might need to open a simple bank account with bankcard (not credit) for contributions to accumulate in. For transparency, you could appoint someone else from your team (a 'treasurer') who can also overlook the account and write cheques.

Given time and dedication in getting the Message out, Independent Candidates can indeed win and profoundly ameliorate society. When the kitty permits, this second stage would include, for example, small ads in the local press. Acquire more supporters and their small contributions amount to a larger kitty *in toto*.

Only twenty people donating a manageable $\pounds 25$ or A\$100 (not all at once but between now and when Election Deposits become due), gives you the GB $\pounds 500$ or A\$2000 required for the election deposit. Acquire more supporters, and contributions needed are yet *smaller*.

Note that the election deposit is refunded when the candidate or group gains at least 12¹/₂% UK or 4% Australia, of valid votes in their relevant electoral division. Seen in the perspective of *costs shared amongst the group*, losing an election deposit would not be painful, but, having got under way, you will aim to get far more than "a few per cent of the vote" so that your local group do get their deposit back for renewed campaigning.

As everything is set out in writing (simple broadsheets; press releases), you will be able confidently to refute in speech and writing all antagonistic political rivals and mainstream interviewers.

8. LOOK THE PART.

As an Area Organiser or Candidate for the Campaign, remember, "You never have a second chance to make a first impression."

A political agent would say right away that making appearances either in a video or in person, in jacket, collar and tie shows respect for your audience. Indoors or out, when being videoed *for political purposes*, gents and ladies seeking election do wear appropriate attire. The videos will be accessible for the foreseeable future. So, wherever the meet-up may be, dress respectably and suitably for the occasion. T-shirts, hoodies and vests are out.

Naturally, personal videos between friends and family make no such demands, but we're talking about getting you into parliament. Bear in mind, nobody wants to waste their vote at this dire point in our history, and so everyone voting for you has to feel confident that you are more than simply someone who has got a very fine *message*. They want to see you as a person realistically capable of holding his or her own at Westminster or Canberra and on the national stage, representing to the country at large a superb Program worthy of being adopted by the entire populace.

Restoration legislation utterly <u>quashes</u> the new world order's Orwellian "great reset"! Widespread education on the Common Law Economy and the New National Bank spreads understanding of how We the People should be <u>served</u> by the National Bank, as opposed to being <u>enslaved</u> to private and National Debt by the present-day usurious banking felons and their corrupted servitors in parliament.




