## **RADIOACTIVITY FROM CROPS FED WITH PHOSPHATE 'FERTILISER' IS THE PRINCIPAL CAUSE OF CANCER.**

*An Essay by Kenn d'Oudney.*



According to statistics, cancer is one of the most frequent causes of early mortality in the population. On reading the information provided herein, it is easy to understand why.

That most cancers are caused by radioactivity in commercially-produced crops as a result of the misuse of rock phosphates as 'fertiliser' is indeed news to many people. Yet, information about radioactivity deriving from phosphates has circulated at the highest levels; viz. for example, the endorsers of THE REPORT

(current ISBN 9781902848303). Clinical studies by world respected academics and research institutions establish that radioactive elements are introduced into crops by cultivators.

It is a shock to learn that this knowledge of literally life-and-death significance is not merely ignored, but is to all intents premeditatedly buried by government and the corporately-owned and controlled mass media, and by state (mis)education. This essay is based on some of the information in Part One (of the seven parts) of THE REPORT, which may be referred to for full source attribution, further quoted material, and a large helpful bibliography. Endorsements of THE REPORT by academics, doctors and judges (U.S. & U.K.) are shown below.

### **DISCOVERY.**

The discovery of radioactivity in phosphates was made by Vilma Hunt at Harvard University as long ago as 1964. Searching for sources of radioactivity in the environment, one day, not expecting any result, she checked a pack of cigarettes with a Geiger counter and was amazed to observe a spectacular reaction and reading. Research subsequently confirmed phosphates as the source.

In 1990, U.S. Surgeon General C. Everett Koop concurred with published studies, stating on U.S. national television that radioactivity in crops is source to cancers, explained as follows.

Plant-growth is stimulated by: nitrogen (N); potassium (K); and phosphorus (P). The latter comprises approximately 30 per cent of rock phosphates — *but rock phosphates also contain naturally-occurring radioactive elements in profusion.* In addition to copious quantities of *uranium*, the following radioactive elements present in rock phosphate ‘fertiliser’, are absorbed by crops and are subsequently ingested by humans and animals:

<i>radium-226</i>	<i>radon-222</i>
<i>polonium-210</i>	<i>lead-210</i>

To maximise profits from commercial agriculture, crops such as vegetables, staple food cereals, tobacco, and pasture for animals, are intensely grown using phosphates. In addition to the phosphorus, plants absorb the radioactive elements through their roots.

Hydroponics: it is due principally to the fact that phosphates are crushed and made soluble in water, that *plants* such as tomatoes, squash/courgettes, aubergines, etc., are viably grown — and contaminated — hydroponically, i.e. indoors, in water, with water-borne radioactive chemicals fed to the roots. This is perhaps the most efficient method of delivering radioactivity to a plant.

### **RADIATION AND DNA.**

Amongst the types of radiation, ionising *alpha radiation* is long-established as especially causative of cancer and leukæmia, and it afflicts people with great harm in numerous other ways.

Human and animal bodies are made up of cells which replicate before ageing and dying off. DNA (molecular deoxyribonucleic acid) within the nucleus of cells is the genetic information ‘blueprint’ or ‘recipe’ from which cells replicate. Radiation

represents a source of danger to humans and animals which they are not effectively equipped to resist.

Radioactivity interferes with DNA at the nuclear atomic and molecular level. When genetic information controlling cell replication is deformed, cells can over-replicate, grow into malignant tumours, and spread (metastasis).

Following the nuclear explosions at Hiroshima, Nagasaki and Chernobyl, the consequential disease of epidemic proportions in the nearby populations, was (and is) due principally to *alpha radiation*. The harm from radiation derived from phosphates, though not so easily understood and obvious as that which is associated with a nuclear explosion, can be nonetheless injurious and fatal. Scientists recognise the danger to living things from beta radiation emitted by lead-210, which has a radioactive half-life of 21 years. Alpha radiation can be twenty times more damaging.

Consumption of any plants grown with phosphates in or out of doors is a grave health risk. Doctor Edward Martell, a radio-chemist of the U.S. National Center for Atmospheric Research, in his paper published in Proceedings of the U.S. National Academy of Science, states that enough *polonium-210* is absorbed by tobacco for *alpha radiation* from the polonium alone to be the cause of at least 95 per cent of lung cancer in tobacco smokers.

Radiation produces many other adverse conditions in the human, characterised by general ill-health and reduced immune-system efficiency; leukaemia; mental and physical handicaps and deformities; teratoma (congenital tumour); Siamese (conjoined) twins; teratogeny (production of infant mutant monsters); and birth defects. Infertility and teratogeny result from irradiation of DNA within sperm and ova. Unborn infants can receive pathogenic, leukæmogenic and carcinogenic doses of radioactivity via the mother's bloodstream.

Note that radiation, particularly the sun's ultraviolet light, is a cause of skin cancer.

### RADIOACTIVE 'FERTILISER'.

Tobacco and other crops have been cultivated for many decades with the use of phosphates. Interestingly, the clinical evidence of official empirical\* studies exonerates smoke-tar from carcinosis allegations and speculations. In addition to the polonium alone being responsible for causing up to, or more than, nine out of ten cases of lung cancer, the evidence demonstrates radiation as principal cause to all carcinosis in humans. The death-rate from lung cancer is *the same* from the smoking of *low-tar* as from *high-tar* cigarettes: hence, not the various chemicals in vegetative smoke-tar but *radioactivity* is confirmed as cause of the cancers; viz. UCLA School of Medicine Long-term Pulmonary Studies, 1969-1997; Donald P. Tashkin, M.D., Vol. 155, American Journal of Respiratory & Critical Care Medicine; U.S. National Institute of Health Study, Lancet, Sept., 1983, etc.

\*Note: *empirical*, i.e. 'hands-on', actual use by human test subjects.

Whereas the acutely addictive substance nicotine in tobacco can cause constriction of the pulmonary system (lungs) and Buerger's Disease (constriction of the vascular system, which can lead to gangrene and amputation of limbs), the smoke-tar itself is exonerated of carcinogens. It is not the plant's naturally-occurring smoke-tar chemicals, but *radiation* which is confirmed as the cause of cancers in tobacco smokers. Research by Beverly Cohen and Naomi Harley, of New York

University Medical Center, established that *tobacco smokers who give up, have five years later almost as much lower lung radioactivity as do active tobacco smokers.*

Radioactive elements within *non-smokers* derive from food crops cultivated in soil poisoned by phosphates. Radio-isotopes are conveyed by the bloodstream to all parts of the body, accumulating in breasts, prostate and sex glands, liver, bone marrow, kidneys, lymph nodes, pancreas, and thyroid. ‘Unaccountable’ and much wrongly-attributed pathogeny results from radioactivity in our food.

*Significantly, the most common incidence of malignant tumours and cancer occurs within the bowels and stomach, accounting for 24 per cent of diseased organ location.*

While circulating in the bloodstream, the radiation is further indicated to cause cardio-vascular degeneration and associated disease, coronaries and stroke. Calcified blood plaques of sufferers of arteriosclerosis (hardened arteries) have been shown to contain polonium-210 and lead-210. The huge number of people who contract cancers, including those who never smoke, is explicated by the radioactive aspect of phosphates.

### **RADIOACTIVE ‘ORGANIC’ OR ‘BIO’ FOOD.**

Radioactive phosphates are used to boost crop growth in commercial food production worldwide, a big business the greater part of which is controlled by a minority of giant corporations.

#### ***Definition. Organic:***

- (i) in Chemistry, the chemistry of carbon compounds;
- (ii) in horti- and agriculture, crops produced using fertilisers and pesticides *exclusively of carbonic plant or animal origin.*

Food sold as ‘ORGANIC’ or ‘BIO’ can be intensely radioactive: farmers using rock phosphates duplicitously define themselves and their produce as “organic” — because rock phosphates come from “naturally-occurring” rather than manufactured sources. In this way, commercial producers of food mislead their buying public into believing that their food is ‘organically’ produced. However, *genuine* organic fertilisers only derive from carbon-based sources; for example, guano, manure, hoof and horn, dried blood, soot, bonemeal, fishmeal, and woodash — *not from rock phosphates.*

Farmers rely on phosphates and manure spread on the land to produce crops of pasture and animal feed, with the result that the feed, the subsequent ‘manure’ derived from the animals, the ‘food’, that is, the flesh of carcasses of cows, sheep, chickens, etc., and the milk, cheese and dairy products, can contain deadly radioactive carcinogens and pathogens.

### THE REPORT.

THE REPORT ISBN 9781902848303 collates the Findings of Fact which establish that radioactivity in crops is caused by phosphates being misused as 'fertiliser'. In full knowledge of the radiation in phosphates, with complete impunity, corporations and owned subsidiaries import the phosphates, own and work the farmland, distribute, market and advertise the produce, and own the hyper- and supermarkets where it is sold. As a result of their motivation to maximise profits, it is a premeditated certainty that radioactivity is inserted into the bodies of the mass urban populations of humans, killing many, and causing grievous harm to innumerable others.

Cheap rock phosphates are spread every year onto the food-producing grasslands of Europe, the Steppes of Russia, the Prairies of America, and throughout Asia, Australia, Africa and South America. If the equivalent of only one-hundredth part of one per cent of the radioactivity spread every year onto the Prairies, escaped by accident from a nuclear facility, there would be a resounding hue and cry from the mass media, politicians and parties, and the pseudo-green groups. (Viz: the mishap at Three Mile Island nuclear power station.) There would also be severe incrimination of the culprits.

Yet, the money-motivated ruin by phosphates of *all* the world's prime farmlands with many hundreds of thousands of consequential annual human mortalities, has the tacit consent of the press and pretentious corporate-funded 'green' and 'conservation' groups, and has been, and is, knowingly permitted and thus *abetted* by judicable\* politicians.

\**Definition.* judicable, that which may be tried by jury in a court of law.

### PLUTOCRACY AND EARLY MORTALITY.

As cancer is a widespread cause of early mortality in the population, the question must be asked as to *why* government and mass media do not report on these crucial matters truthfully? *Owners* of the implacable multi-national and national pharmaceutical manufacturers are financially linked with the central and other banks and finance houses, the oil and petro-chemical corporations, the armaments and auto industries, the alcohol and caffeinated beverage businesses, the tobacco cultivators and traders, and other manufacturing, agricultural, retail and service companies, newspapers, publishing, press, radio, television and advertising companies.

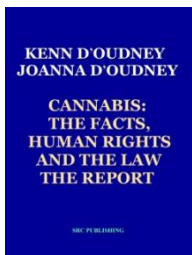

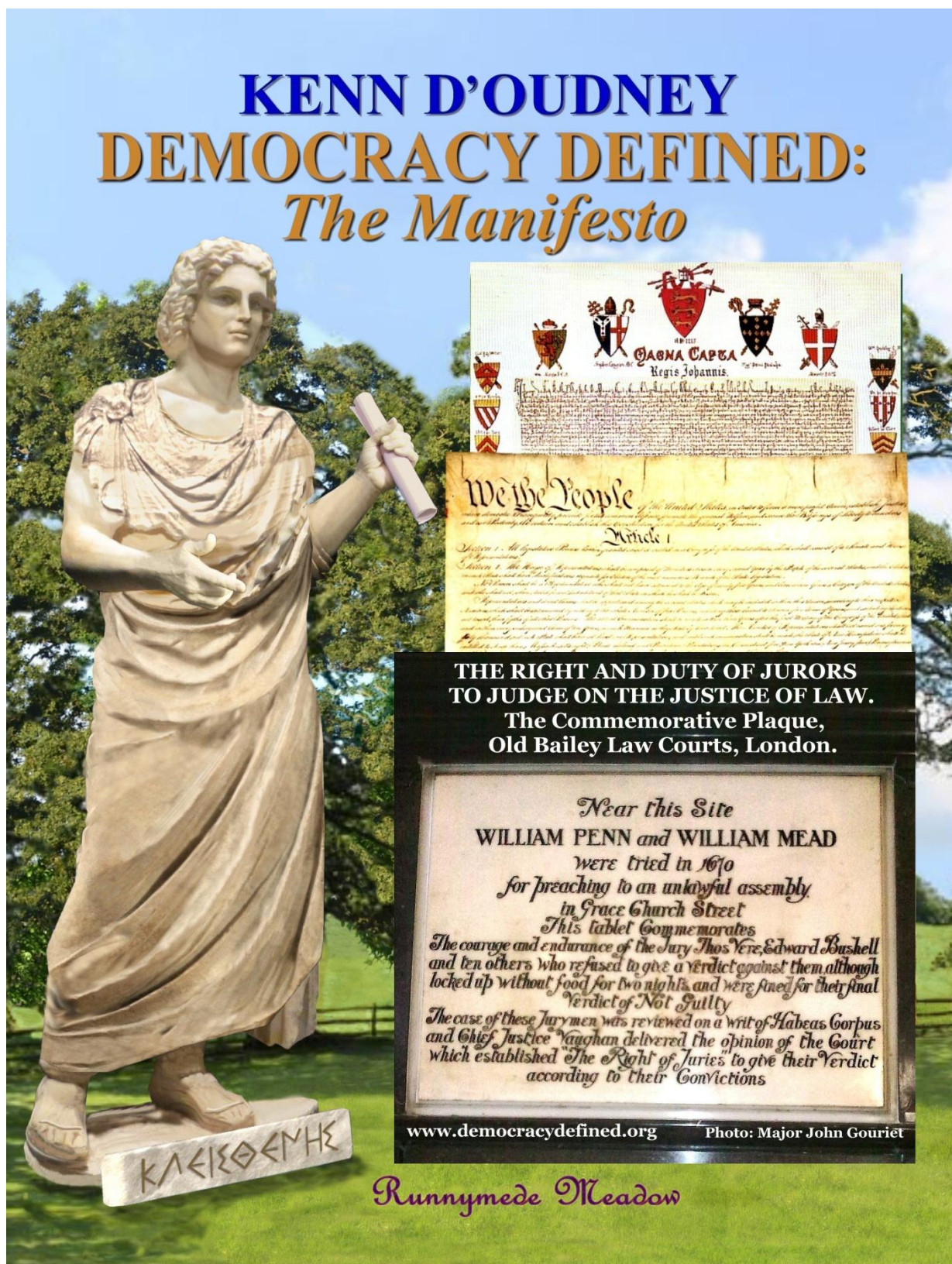

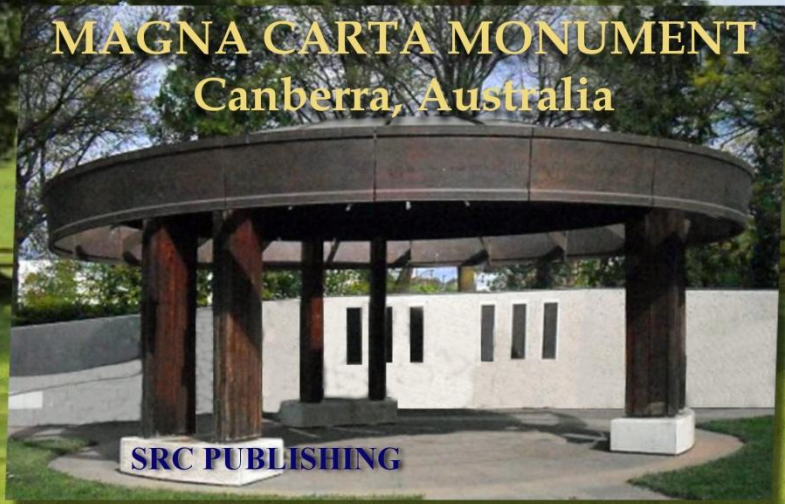

### MAGNA CARTA MONUMENT Canberra, Australia

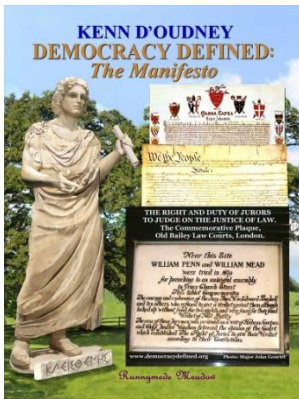
