THE ROAD TO HELL IS PAVED WITH GOOD INTENTIONS.*

In order to assess the value or otherwise of the words and deeds of Dr. Gene Sharp, it is first of all essential to establish the criteria by which his activities may be judged. Evidently, such value judgements first require a proper understanding be achieved semantically; that is, by setting out the signification (meaning) and origin of the word *democracy* itself. From this, it follows that it is straightforward to recognise the difference between what Sharp considers “democracy” to be, and a lexicographically correct understanding of the word, with the true significance of definitive democracy to all of humankind explained.

Sharp was preoccupied by his particular image of “democracy,” yet he never set out what the word actually means—other than to propose that ‘democracy’ was a form of ‘majority rule’ brought about by peaceful, or ‘pacifist’, majority techniques. De facto, this is Ghandi’s *satya graha* by another name; a well-proven advocacy of peaceful non-cooperation to achieve political change, for example, to a different or new government. However, the definitive point to note is that such a *movement* does not necessarily result in, let alone does it produce, “*democracy*”!

Indeed, it is safe to say that in various instances where Sharp’s ideas have been propagated, one demagogic régime has been replaced by another which veers towards self-interest and new forms of social injustice! The lesson we all learn from both the socio-political theory and the practical aspects, is that folk who have aspirations for increased freedom require understanding of certain Universal Principles. For it is these very Principles which providentially bestow upon us All, the rules which must prevail within any society for it to earn the epithet: Democracy, and for the People to realise their precious ambitions.

These universal rules, more frequently called Natural Law and Common Law, comprise the indispensable Mechanism which successfully achieves the emancipation, not of a minority, nor even of a majority, but of the entire People. Let us be reminded of its meaning, for the word ‘democracy’ is widely abused and ‘defined’ incorrectly: Democracy is a state of society realised *neither* by referenda (mass voting for new laws), *nor* by suffrage (electoral voting for representatives), *nor* by the representatives’ majorities’ legislative voting. Electoral voting, majority rule and ‘*consensus politics*’ neither create nor define democracy... Democracy is founded on Common Law Trial by Jury, derived from the Hellenic Athenian Constitution of government by Trial by Jury.

Through its etymology, history and signification, the word democracy designates the constitutional justice system. **Democracy** is based on the *sovereignty** of the individual citizen-juror as the final arbiter of law and protection of the people from tyranny.

**Definition*. Sovereignty, pre-eminence; the supreme and independent power expressed through the making and enforcing of the laws.

Hellenic Greece of the Constitution of government by Trial by Jury received from the Athenians *the defining epithet*, Democracy, demokratia.

History proves that *any* society *devoid* of the Juror's Powers, Procedures, Rights and Duty to protect the populace from the enforcement of unjust laws (by judging on the justice of the law and its enforcement in every case), *inevitably* trends towards tyrannical misrule. Yet, alas, 'majority rule' is the message sent by Gene Sharp. Such a message is totally devoid of the Mechanism unique to the foundation of Democratic Civilisation: **Constitutional Common Law Trial by Jury**.

The lethal implications of 'majority rule' through peaceful electoral voting were exemplified in the Nineteen Thirties within the Third Reich, with its Nürnberg Race Laws.

Indeed, looked at from a different angle, Sharp indicated by what he did not say about democracy, that he knew *neither* the real meaning *nor* the origin, implications, and true benefits to the populace which derive from a *genuine* State of Democracy founded on the Constitution of government by Trial by Jury. No doubt Gene Sharp was *well-intentioned*; a kind and generous human being, but we are not here to judge his personal character. Rather, we are discussing the value or otherwise of him or anyone else spreading fallacies about what is *de facto*, majority rule! Yet, what a fine 'prophet' he would have been instead, had his long-term advocacy been that of the profound message which truly is... Democracy.

THOMAS JEFFERSON ACKNOWLEDGES THE JUROR'S SOVEREIGNTY.

Definition (Note). Regarding the legal, constitutional signification of the word sovereignty, as seen in Chapter Three, distinction must be drawn between the words *sovereign* and *sovereignty*. Also see section in Chapter Two regarding the London Old Bailey Law Courts Commemorative Plaque celebrating The Right and Duty of the Juror to judge on the justice of the law itself.

Nota Bene: The juror is sovereign over the law (statute) whenever the juror's Powers, Procedures, Rights and Duties prescribed by the Common Law operate without intervention. Democracy is upheld when the Common Law Trial by Jury is the exclusive Justice System. Trial by Jury thus enables the people to decide their Laws and Liberties *for themselves*, and Thomas Jefferson celebrated this ideal status quo in correspondence with Thomas Paine.

Lawyer, Author of the Declaration of Independence, co-Founder of the Democratic-Republican Party and Third President of the United States, Thomas Jefferson acknowledged his personal belief and understanding that the U.S. Constitution and its Common Law Trial by Jury endow the common person as juror with Sovereignty. Jefferson adopts the inestimably precious legacy of the Hellenes, the civilised Constitution of government by Trial by Jury.

THE DEMOCRATIC PRINCIPLE.

The democratic principle of our traditional Western Constitutions' Trial by Jury is that it is the Will of the People represented by indiscriminately chosen jurors, not the will of the court or the current transient government, which must determine what laws shall be established, maintained, and how they are enforced. In this way, Trial by Jury is the common law's mechanism of authority by which all the rights of all the People are protected, and on which all rights depend. Hence, Thomas Jefferson's "anchor":

“I consider Trial by Jury as the only anchor yet imagined by man, by which a government can be held to the principles of its constitution.”¹

Jefferson thus held paramount the role of the juror in society and judicature.

Definition. judicature, within definitive democracies, the power of dispensing justice by the Trial by Jury; the Common Law Justice System of Trial by Jury courts; jurisdiction; the office of juror, i.e., as judge.

Since its earliest inception in the mists of pre-historical antiquity, common law Trial by Jury has remained the civilised method for combating crime: both common crime, and high crimes committed by, or in the name of, government. Trial by Jury is the legitimate means by which those who acquire and abuse power or government can be held responsible and brought to account by the humblest of people in a society.

“Judicium parium is the sole peaceful means known to humankind by which the rights of the weakest innocent citizen prevail over a massive and potentially oppressive state power.”¹

**The road to hell is paved with good intentions* is an Old English (Sixteenth Century or earlier) proverb with the meaning that a “good intention” *without taking the action requisite to fulfil it*, is less than merely meaningless; it is iniquitous hypocrisy!

In an age when few had even the most rudimentary understandings of our physical universe, ‘heaven’ and ‘hell’ were real places to which everyone goes after their life comes to an end. ‘Heaven’ was the reward for having lived a ‘good’ life; and ‘hell’ was a place to fear and avoid, for “*going to hell*” was a terrifying sentence of purgatory, misery, pain and eternal damnation.

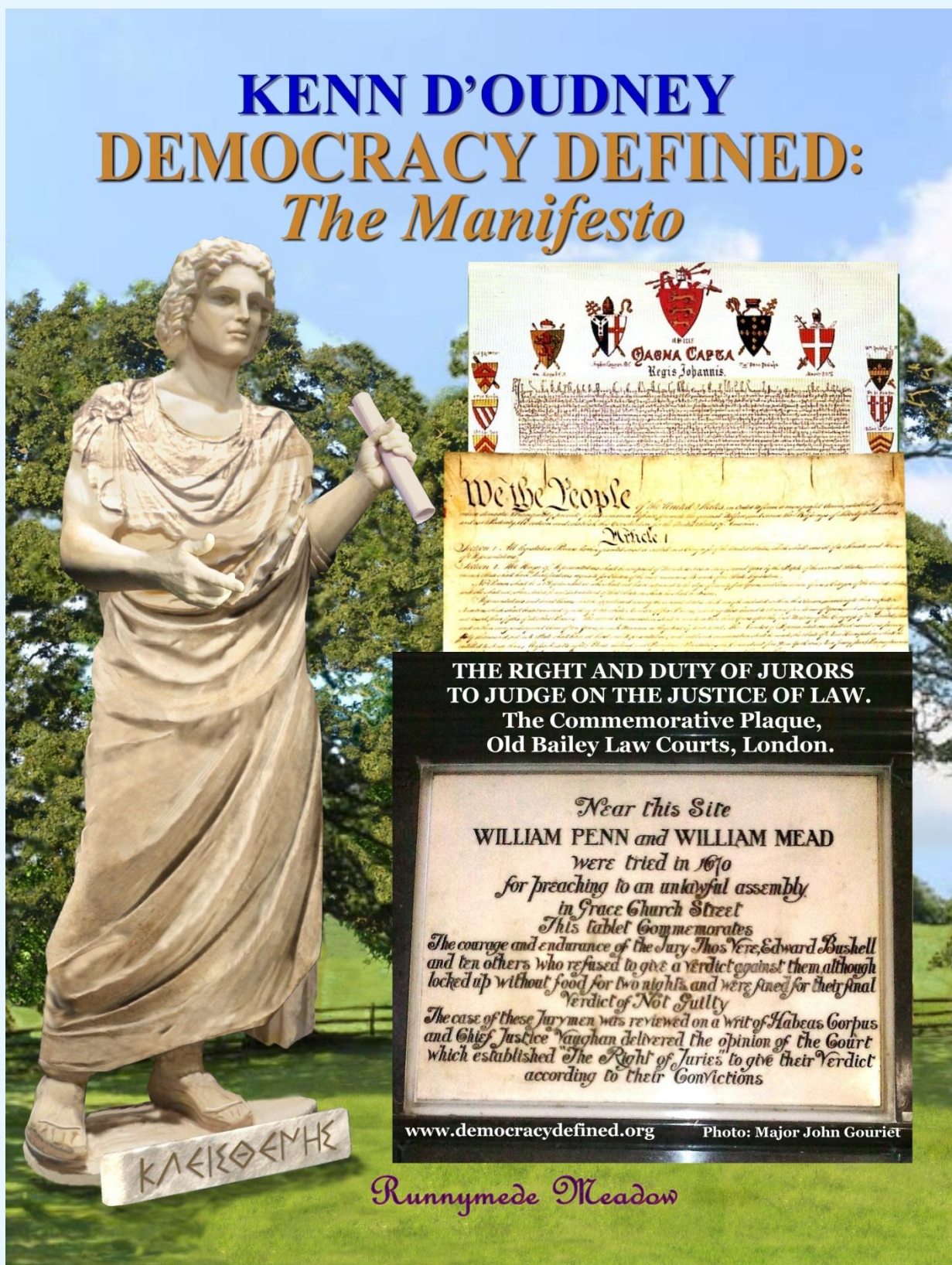

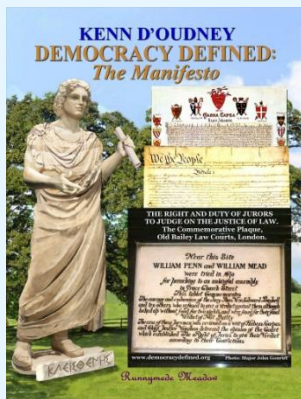
